NEW BUSINESS

General Updates

Mr. Walby provided an update on the transfer station. Reliable Compactor Service has been working on the compactors. Both bins are working now. It has been a slow process due to COVID. No steel available for a while and not enough workers. No customers were turned away during this process. Mr. Walby stated we are trying get quotes for the ground water pumps. We had a water line pipe burst at the transfer station over the holidays.

Titan Wealth Advisors our investment consultants have transferred all funds from Morgan Stanley to Titan Wealth. They will come to board meeting for quarterly reports. We will receive quarterly invoices of \$7500.00 for their fees. Total cost is \$30,000.00 for the year. Approximately, \$5,000 for SMDA and \$5,000 for SEMSD cash accounts and \$20,000 for pension account.

The EGLE meeting regarding Site 9/9a penalties and fines was cancelled and re-scheduled for January 26, 2022.

Mr. Walby reported that Dianne Schelosky is having surgery on January 21, 2022 and will be on medical leave for 6 to 8 weeks. During that time, she has been set up to work from home and we will have temporary help and incur extra costs to do her work.

Some of our SMDA/SEMSD employees have had COVID. We are doing our best to juggle employees around.
