Director of Operations

The Director of Operations update was provided by Kip Walby.

NEW BUSINESS

Transfer Station Update

Mr. Walby presented the transfer station update. The net profit shows \$148,930.43. January went well even though we only had one side of the compactor working. The tonnage of MSW continues to go up month after month. Compost is down because its winter. The outstanding summary amount continues to go down. Campo Disposal are making payments.

General Updates

The agreement with City of Roseville regarding the compost issue has not received. Some minor language needed to be corrected. We are getting prices to install cameras at the transfer station.

Mr. Walby provided an update on an email he received from Department of Environmental, Great Lakes, and Energy (EGLE) today. He received a response from Cynthia Mollenhour regarding Site 9/9a regarding the operations and maintenance and stipulated penalties. Mr. Walby read the last paragraph from EGLE's letter dated January 23, 2022. "The SMDA requested EGLE to freeze the accrual stipulated penalties while SMDA works towards achieving compliance with the consent decree. EGLE has considered SMDA request and is agreeable to stopping the accrual of stipulated penalties and holding the remainder \$24,717,624.80 in abeyance. EGLE will continue to review SMDA's progress toward achieving compliance with the consent decree and may continue to assess stipulated penalties until the violations are resolved." Mr. Walby explained he thought this was a step in the right direction. EGLE is asking for 0.1% payment toward the stipulated penalties for \$24,742.37. The Board had a discussion regarding paying the stipulated penalties.

MOTION by Binson, supported by Lucido to approve to pay \$24,742.37 to EGLE which is 0.1% of the stipulated penalties for Site 9/9a.
