FOIA Policy

Tim Tomlinson presented the Freedom of Information Procedures and Guidelines Policy. The purpose of the policy is to establish procedures and guidelines governing the release of public records, pursuant toto Public Act 442 of 1976. This policy establishes a process and procedures for the release of public documents, establishes a policy to recover costs associated with requests and establishes a procedure for appeals.

He reported that Ms. Mollenhour sounded encouraging and stated that the penalties and interest was not really an incentive anymore. EGLE may consider freezing the penalties and interest. Mr. Walby stated he did reach out to the Attorney General's office Brian Neville's office.

The SMDA is expecting two letters from EGLE, one regarding the penalties and interest and the another from Melissa Powers-Taylor regarding back up wells.

Mr. Ghanam stated he reached out to Attorney General, Paul Genito and State Representative, Lori Stone. Mr. Ghanam explained what was happening and he stated that Mr. Genito would be more than happy to come to a board meeting to discuss. Mr. Ghaman also spoke to Tracey Castinetti from the DEQ, the regional manager.

Mr. Walby provided an update on the transfer station compost issue with the City of Roseville. Roseville's Attorney sent us the agreement and we notice we had to make a correction in the language. We made the correction, and it has been returned to them for review. Hopefully by the next meeting we will have the final agreement.

Mr. Walby shared pictures of a cylinder at the transfer station. A hydraulic compressor is leaking at the hoses and fittings and leaking hydraulic fluid. Mr. Ghanam stated they have a hose maker at the City of Warren. If they could provide a picture with the dimension, they will be able to make them. The street sweeper is working out great. The EGLE was out in December and waiting for their letter.

Mr. Seidel provided an update on the Red Run bike path by the Freedom Hill/Fostoria Landfill. The SMDA board has asked to keep an eye on their construction and AEW will do spot inspections to make sure all of our work at the landfill it protected.
