#### **Director of Operations**

#### **NEW BUSINESS**

#### Transfer Station Pumps

The transfer station storm pumps failed in December, 2021. A temporary portable pump was installed while we pursued replacement pumps. Due to the age of the pumps repairing of the pumps was not an option. We were able to get three quotes. One by KSB for \$27.932.00, one by Kennedy using the manufacturer Barnes for \$32,830.00 and another one by Kennedy using manufacturer Flygt for \$39,080.00. Mr. Walby stated there are two pumps at the facility and probably installed around 1980. Mr. Walby and Mr. Seidel recommend purchasing two pumps from KSB for \$27,932.00. They will be installed by Fischer Brothers.

MOTION by Babcock, supported by Binson to approve the purchase and installation of the storm pumps from KSB for \$27,932.00 at the transfer station.

#### **EGLE Demand Letter**

Mr. Walby provided an update on letter received from Department of Environmental, Great Lakes, and Energy (EGLE). He provided the response from Cynthia Mollenhour dated February 23, 2022 for the board to review. The letter states they will agree to freeze stipulated penalties while SMDA works towards achieving compliance with the consent decree. EGLE is asking for 0.1% payment toward the stipulated penalties for \$24,742.37. The board approved in a motion to pay the \$24,742.37 at the February 23, 2022 board meeting. Mr. Walby provided a copy of the check in the board packet. The board discussed different strategies working with EGLE and the SMDA funds.

#### Transfer Station Fuel Charges

Mr. Walby explains S.A. Torello has contacted him regarding a gas surcharge. Mr. Torello's letter states a year ago he was paying \$2.95 per gallon and today he is paying \$4.63 per gallon. He uses about 20 gallons round trip from transfer station to Pine Tree Acres landfill and then back to the transfer station. Mr. Torello is requesting a .96 cents increase per ton. If the board agrees to approve the surcharge, if the price of fuel go down then the surcharge should also go down. Tim Tomlinson will create a Letter of Understanding to Mr. Torello. Mr. Walby stated the SMDA will increase their fuel surcharge to the transfer station customers if approved by the board. The SMDA diesel fuel costs have increased too.

MOTION by Binson, supported by Ghanam to approve the .96 cents fuel surcharge increase from S.A. Torello with the Letter of Understanding and allow the SMDA to put a surcharge to their customers invoice for their diesel fuel used at the transfer station.
