Director of Operations

The Director of Operations and Administrator was provided by Kip Walby.

Titan Wealth Advisor 1st Quarter Update

Mr. VandenHaute provided an 1st quarter update of the SMDA financials. He explained the transition from Morgan Stanley to TD Ameritrade. Account #1 is the SMDA Site 9/9a Insurance settlement and account #2 is the SMDA General Fund. The intension was to place both accounts in 1–5-year Laddered CD's. He explained the yield curve has been traditionally flat until the Feds starting to make some moves. Mr. VanderHaute stated the 1–2-year Laddered CD's are a better strategy. He explained based on everything they have bought thus far, the interest coming in annually is approximately \$10,000.00 General account and \$90,000 for Site 9/9a account. Mr. VanderHaute asked the board for a motion to deploy the assets in a shorter term to 1, 2, 3- year Laddered CD's.

representative from EGLE will be Beth Mead-O'Brien a Senior Project Manager. Mr. Walby has invited Ms. Mead-O'Brien to come out in early June, 2022 when we are doing the testing at Site 9/9a. Mr. Walby feels we are still moving in the right direction. We are getting everything in the repository. TRC is working on the conceptual site model. Mr. Seidel explained Ms. Power-Taylor wanted to see a couple of reports in a row that that show we are not having any issues that matches with the conceptual site model. Mr. Seidel stated we have a lot of data and reports perhaps we can use that. The hope is the new project manager transitions well.

Pictures of the Red Run streambank restoration and the bike path was shown to the Board. Macomb County Public Works is making progress. Mr. Walby explained we are getting a considerable number of calls from new clients wanting to dump at the transfer station. He would like to have a discussion with the SMDA Board at the next meeting.
