#### **NEW BUSINESS**

#### **Director of Operations**

The Director of Operations and Administrator was provided by Kip Walby.

Titan Wealth 2<sup>nd</sup> Quarter Update

Kevin VandenHaute and Mark Mueller from Titan Wealth Advisors provided an update on the 2<sup>nd</sup> quarter SMDA funds. He started with the Site 9/9a funds. The target was to be 40% in money market and 60% in laddered CD's. As of June 30, 2022 the Site 9/9a funds are at 37% in money market and 63% in laddered CD's. At the last meeting it was agreed to not to invest in 1 year. The estimate annual yield if 1.53% and estimate annual interest just under \$10,000.00 a year. The SMDA General Account target was 15% in money market and 85% in laddered CD's. As of June 30, 2022, we are 16% in money market and 84% in laddered CD's. More emphasis on weighted 1-2 years with estimated yield 1.97% and estimated annual interest \$80,146.00 a year based on the CD's. Mr. VandenHaute stated we are fully vested as of today.
