Director of Operations

The Operations and Administrator update was provided by Kip Walby.

2024 Annual Monitoring Well Payments

Mr. Seidel explained the annual monitoring well payments at Site 9/9a. Some of the groundwater from the landfill has run offsite and we are required by EGIE to put offsite monitoring wells on private property. The neighboring property owners are paid \$100 annually in advance for access to each monitoring well located on their properties. For the calendar year 2024, a total of \$2,900 should be paid to eight neighboring property owners for access to twenty-nine monitoring wells. Mr. Seidel showed a map of Site 9/9a and the location of the wells. The property at 52097 Card Road has recently changed ownership, and we are in the process of obtaining a signed agreement with the new owner. We recommend waiting on sending payment until this is obtained.
