## **Director of Operations**

The Operations and Administrator update was provided by Kip Walby.

#### Titan Wealth Update

Kevin VandenHault from Titan Wealth Advisors provided an update on the SMDA 4<sup>th</sup> quarter financial as of 12/31/23. The general account shows 22.7% in treasures with an estimated yield of 5.47%. The laddered CD's has 72.6% with large amount maturing within the next six months. We are moving out of CD's and putting them into treasuries. We have 4.7% in money market account. The 9/9a account shows 1% in money market. Took out \$250,000 in the 4<sup>th</sup> quarter. Two CD's remaining at \$234,000. Mr. VandenHault showed the cash flow of 2024 of general account with CD's maturing each month keeping \$250,000.00 into the 2<sup>nd</sup> quarter. Charles Schwab bought Ameritrade.

#### **General Updates**

Mr. Walby reported that Bethesda School is building a football field located by Freedom Hill/Fostoria Landfill. Mr. Seidel stated they are building a new track, sports arena, bleachers, and some small recreation buildings. They asked about in 2015 gas migrated offsite. AEW did looked into this matter and found no reports of gas migrating beyond the perimeter gas probe. We have met with City of Sterling Heights and will continue to meet once a year and share data with them.

Mr. Walby reported a meeting with the City of Warren, Dave Muzzarelli and Richard Fox regarding their transfer station. We walked away with a good consensus that work needs to be
